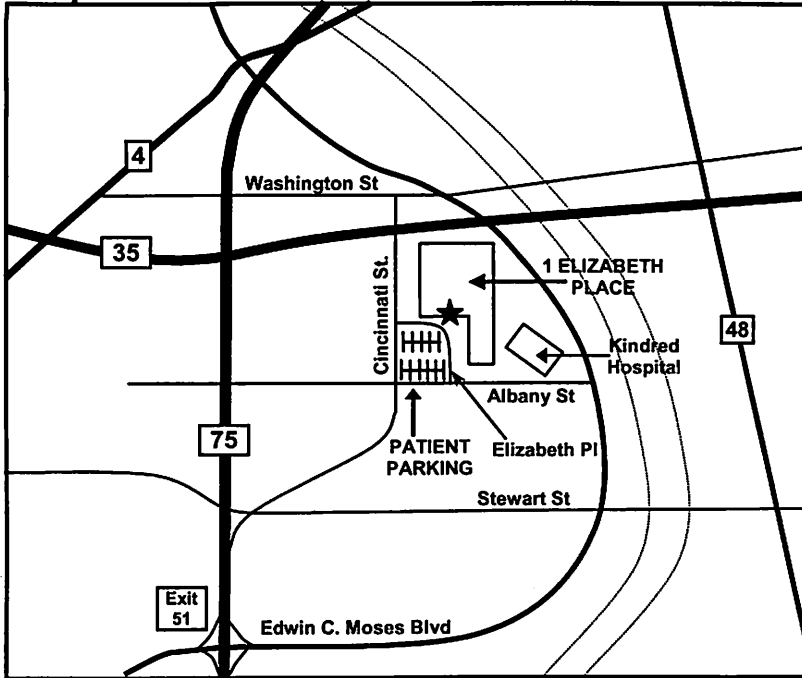

From North of Dayton:

- Travel SOUTH on I-75 toward Dayton
- Take Exit 51 (Edwin C. Moses Blvd)
- Turn LEFT onto Edwin C. Moses Blvd.
- Turn LEFT onto Albany St.
- Turn RIGHT onto Elizabeth Pl.

From South of Dayton:

- Travel NORTH on I-75 toward Dayton
- Take Exit 51 (Edwin C. Moses Blvd)
- Turn RIGHT onto Edwin C. Moses Blvd.
- Turn LEFT onto Albany St.
- Turn RIGHT onto Elizabeth Pl.

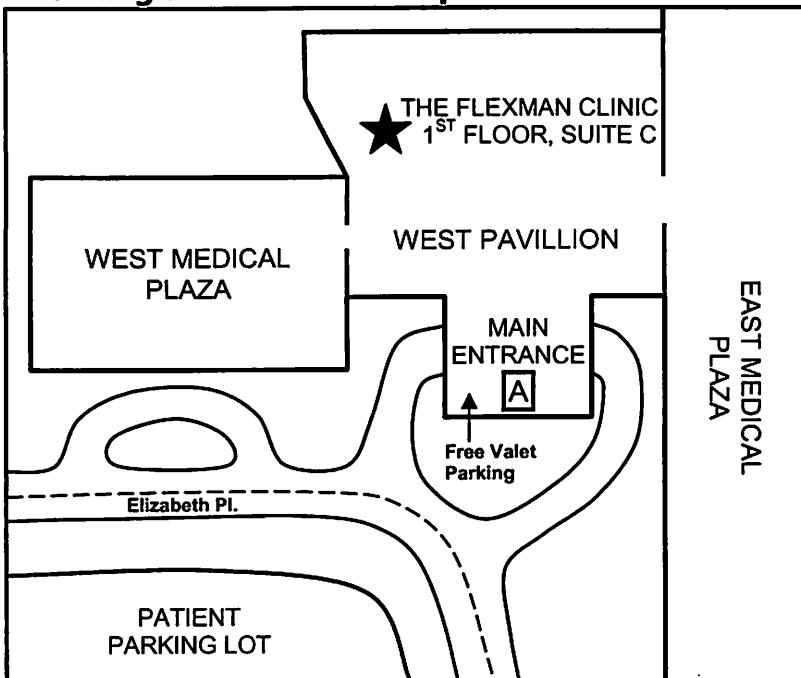
From East of Dayton:

- Travel WEST on US-35 toward Dayton
- Merge onto I-75 SOUTH
- Take Exit 51 (Edwin C. Moses Blvd)
- Turn LEFT onto Edwin C. Moses Blvd.
- Turn LEFT onto Albany St.
- Turn RIGHT onto Elizabeth Pl.

From West of Dayton:

- Travel EAST on US-35 toward Dayton
- Merge onto I-75 SOUTH
- Take Exit 51 (Edwin C. Moses Blvd)
- Turn LEFT onto Edwin C. Moses Blvd.
- Turn LEFT onto Albany St.
- Turn RIGHT onto Elizabeth Pl.

We ask that you arrive **10 MINUTES** early for your appointment. If for any reason you need to cancel your appointment, please provide 24-hrs notice. Failure to do so may result in your appointment not being rescheduled.

YOU ARE REQUIRED TO PROVIDE ACTIVE PROOF OF INSURANCE AT THE TIME OF YOUR APPOINTMENT. IF YOU ARE NOT ABLE TO PROVIDE THIS INFORMATION, YOU WILL NOT BE SEEN FOR YOUR APPOINTMENT.

Please dress comfortably. If you are scheduled to see one of our therapists, you will be seen for 45 to 50 minutes to discuss your concerns and to develop an effective, individualized treatment plan.

If you are scheduled to see Dr. Flexman for an evaluation, he will meet with you to discuss the necessary history and will determine the tests required to best evaluate and understand your concerns. We will begin some of the testing at the time of your initial visit. Insurance does not always allow us to complete all of the testing in one appointment; therefore, you will be scheduled to return for a second appointment to complete the evaluation. The first appointment will last approximately 1 to 1 ½ hours. The second appointment is typically 1 to 3 hours.

At the time of your first appointment, please bring:

- A list of your current medications
- Reading glasses, if needed
- Insurance card(s)
- Valid photo ID
- Cash, check or credit card to pay your co-pay, if applicable
- **There is a one-time \$20.00 testing materials fee to be collected at the time of the first appointment. This is an office fee that cannot be billed to insurance. Your second appointment will not be scheduled until this fee is paid. (This fee does not apply to active Caresource, Medicaid, and Worker's Compensation).**

If you are going to be more than **10 minutes late** for your appointment, please call the office at (937) 256-5300 so we can determine if you will still be able to be seen that day or if we need to reschedule your appointment.

Please review the enclosed information, including our privacy notice, financial/billing policy, patient rights notice, and a map to our location. Please complete the enclosed Client Registration form **BEFORE** arriving for your appointment. If we can further assist you or if you have any questions, please do not hesitate to contact us.
